Personal Injury Liability Release Agreement



I, hereby acknowledge and agree to the following, as a condition of participating in a KenyaRelief.org mission project:

- 1. My involvement and/or participation in a **KenyaRelief.org Team** is voluntary, and I am acting under my own free will.
- 2. There is a risk of danger, bodily harm, injury, emotional stress, or death as a result of my participation. The risks arise from but not limited to risks which I normally face personally or professionally, health hazards to poor food and water, diseases, pests and poor sanitation, potential danger from lack of control over locals in country travel to, potential injury while performing work tasks and inadequate medical facilities, etc.
- 3. There is the potential for risks and dangers that may not be obvious or reasonably foreseeable at this time.
- 4. I do not have any medical ailments, physical limitations, or mental disabilities that will affect my ability to participate in **this mission trip**.
- 5. **KenyaRelief.org** undertakes no direct legal or financial responsibility for my personal safety or well-being when I am participating in **the mission trip.**
- 6. I assume the risks, including, but not limited to, those outlined in Section 3 of this agreement.
- 7. I forever release KenyaRelief.org, and all related participants from any and all claims and causes of action that I or my representatives now have or may have in the future for personal injury, property damage or wrongful death occurring to me, arising out of participation in the mission trip.
- 8. I am 100% liable for all medical expenses incurred as a result of any injury or property damage during my participation in **the mission trip**.
- 9. I hereby release and discharge KenyaRelief.org and mission journey leaders from all claims, demands, actions, judgments and executions which I ever had, or now have, or may have, or which my heirs, executors, administrators, or assigns may have or claim to have, against the mission organization, their agents, their officers and their successors or assigns for all personal injuries to property, real or personal, caused by, arising out of, the mission trip.
- 10. In the event that any one or more of the provisions of this agreement shall be held to be invalid, illegal, unenforceable or in conflict with the law according to the jurisdiction of the state of **Alabama**, the remaining portions will not be invalidated, and shall remain in full force and effect.
- 11. This is a legally binding contract, but it is not meant to pronounce any claims or defenses that are legally prohibited.
